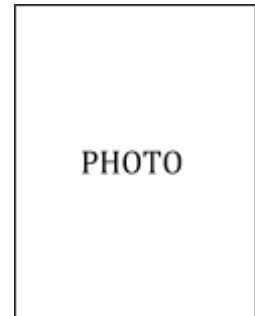

Agreement & Declaration of Canaan Scholarship Programme.

I, _____, parent of _____, hereby declare, acknowledge, agree, and confirm that accepting this scholarship means that I agree to the following terms and conditions:

1. Applicants can only accept the scholarship by completing the full enrollment process of the school.
2. The scholarship is neither transferable nor exchangeable for cash or other alternatives. In the event that a student decides to discontinue his/her studies at WMSI, the scholarship will be forfeited.
3. All supporting documents must be original or certified true copies by the relevant authorities.
4. The scholarship tenure is fixed. Deferments are strongly discouraged and will only be considered on passionate grounds on a case-by-case basis.
5. All Scholarship recipients will be required to:
 - a. maintain 60% and above for all subjects.
 - b. be active in the school's extra-curricular activities.
 - c. comply with all the school rules and regulations at all times.
 - d. ensure all other outstanding school fees are paid on time.
 - e. attend a scholarship ceremony.
 - f. refrain from posting remarks that damage the school's reputation (through any medium).
 - g. be model students at all times whether on or off school grounds.
6. Failure to comply with the conditions above without an acceptable reason to the school may result in suspension or termination of the scholarship.
7. In the event that a scholarship recipient's enrollment is suspended or terminated by WMSI at any point of time before the completion of the scholarship programme, the scholarship shall also be automatically terminated.
8. Should the recipient accept any other scholarship of any amount whatsoever, the School must be notified and WMSI reserves the right to terminate the existing scholarship.
9. WMSI reserves the right to involve the scholarship recipients in interviews, advertisements, photography, or other activities to promote the school. All products of these activities are the copyright of WMSI and can be used without prior written or verbal permission.
10. WMSI reserves the right to alter, add, or delete any of the terms and conditions of the Canaan Scholarship programme without prior written or verbal notice. All decisions made by the Scholarship panel on matters not covered above are final and binding.
11. WMSI reserves the right to decide on the number/amount of scholarships to be awarded.
